Payment of Fees and Charges

TUITION FEE

The Schedule of Fees and Charges is set by the School Council and reviewed annually. Ravenswood is registered by the Department of Education to accept Overseas Students. An Overseas Student is a student who is not an Australian or New Zealand citizen and who seeks to study as a student on a 500 Visa (formerly 571 Visa). As the School does not receive government subsidies for Overseas Students on 500 Visas, the full fees apply for Tuition.

If there is a vacancy, Overseas Students will be required to show **evidence of English competency in order that they may pursue their studies satisfactorily.**

If a student is accepted for enrolment, government regulations require that private medical insurance be arranged.

A Bond is required by the School before an official acceptance advice is issued, which will then enable a visa to be obtained. It is important for applicants to indicate if they are an Overseas Student, so the School can complete all the government requirements for a visa to be obtained without undue delay, if they are accepted.

Please note that Overseas Students are not eligible for rail or bus concessions cards or free travel.

ACTIVITY FEE

The Activity Fee covers (but is not limited to) educational and School curriculum-related activities including, 'whole of Year Group' incursions, excursions, pastoral care activities and camps.

BOARDING FEE

The Boarding Fee is the same amount for all Year Groups and is in addition to the Tuition Fee.

A Boarding Bond, equivalent to 25% of the annual Boarding Fee, is payable for all new boarding enrolments.

ELECTIVE SUBJECT FEES (YEARS 9-12 - USUALLY CHARGED IN JUNE)

Students undertaking elective subjects may be billed an annual Elective Subject Fee that covers associated curricular costs, in addition to standard classroom costs. Details are available on the Portal.

HIGHER SCHOOL CERTIFICATE (HSC) AND INTERNATIONAL BACCALAUREATE (IB) DIPLOMA CHARGES

The NSW Education Standards Authority levies an administrative fee of approximately \$1,200 on Overseas Students who are candidates for the **Higher School Certificate**. The charge is payable upon application for the examination. Students undertaking the **IB Diploma** will be charged an elective fee: Year 11 \$810 and for Year 12 \$740, to cover the cost of the IB Diploma, Workshop and Examination Fee as set by the International Baccalaureate Organisation (IBO).

ADDITIONAL SUNDRY CHARGES

Additional sundry charges will appear when the student elects to participate in activities such as Saturday Sport, Clubs, Cadets, The Duke of Edinburgh's International Award, Debating, or other co-curricular activities.

Payment of quarterly instalments are due in advance by the first day of each school term. Other sundry charges occur throughout the year and will appear and become due as advised in a respective monthly statement.

AN INVOICE/STATEMENT OF ACCOUNT WILL BE ISSUED EACH MONTH WHEN THERE IS A BALANCE OUTSTANDING

Families may request, by arrangement, to pay fees annually in full by contacting Accounts Receivable:

1 x Annual (charged in January) and applicable for \$500 discount if paid in full by 30 January 2025.

10 x Monthly (charged from January to October) - Signup through the Portal is required - see below.

The following payment options are available:

1. SCHOOL AUTOMATIC PAYMENTS -

online payments:

Logon to the Ravenswood Portal and complete a payment plan with bank account or credit card details, by 4 January 2025.

- Authorise the School to direct debit the account balance each month to pay all charges due. (Invoice/Statement of Account will be sent prior to the scheduled payment.)
- Payments are made via a (Australian only) bank account (no bank fee); or (Australian only) credit card (Visa, MasterCard and American Express). Please note, **credit cards incur a 1.19% surcharge for Visa and Mastercard; and 0.95% for AMEX.**
- Voluntary tax deductible donations to the Ravenswood Building Fund may also be set up.
- **Credit Cards** - via the Ravenswood website or the Portal. Please note, **credit cards incur a 1.19% surcharge for Visa and Mastercard; and 0.95% for AMEX.**

2. BPAY (Biller Code 57 5522), quoting your reference number shown on your Fee Statement.

STUDENT WITHDRAWAL

Where a student intends to leave the school, a full school term's notice in writing is required. If sufficient notice is not received, 25% of the annual tuition fee, plus GST, will be charged in lieu of notice.
